to build a brighter future for homeless animals

For the last 50 years, our centre has been here to protect and shelter homeless, unwanted, and lost animals, originally as HULA Animal Rescue and now as part of the National Animal Welfare Trust family. Whilst our name might have changed, our values have not and we intend to remain an integral part of your local community, with ambitions to help thousands more pets without homes over the next 50 years and beyond.

We can't do it without you. If you've visited our centre recently, you will have seen that the existing buildings are in a sorry state of disrepair and despite all our best efforts over many years, most of them are unsalvageable. We have made a commitment to ensure we continue to offer every pet in crisis first class care and enrichment as well as brand new state of the art accommodation, so that they can begin to leave their trauma behind them as soon as they arrive here.

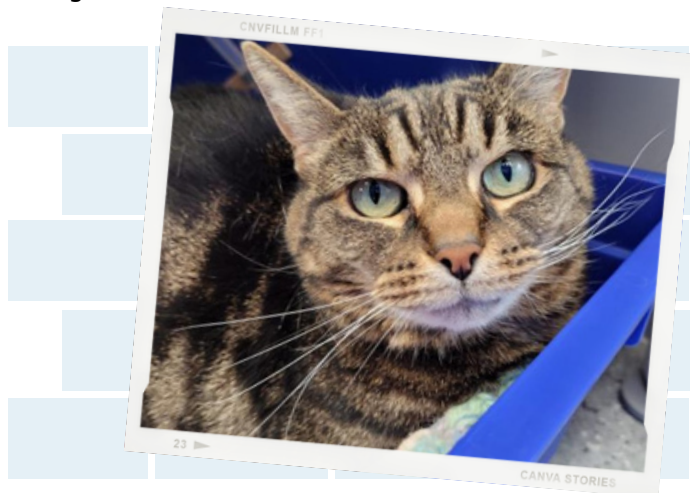
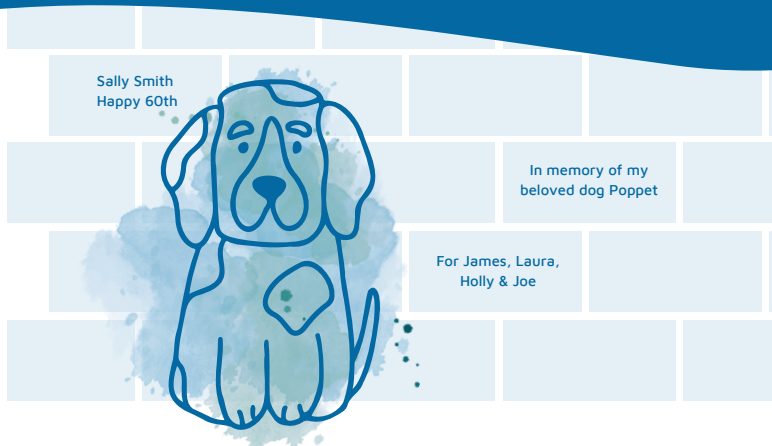
This is where we can offer you the opportunity to be a permanent part of our history, with a brick of your own that will be on display at our rehoming centre for the lifetime of the redevelopment. Your brick will be engraved with a message of your choosing, which might be a tribute to a loved one, a message of hope to the pets who will reside here, or a celebration of your own beloved pet. The decision is yours and your message will be set in stone as a reminder of the part you played in building a safe haven and a brighter future for animals who need it most.



Simply decide what size brick you would like (you have the choice of a 2-line brick for £50, a 4-line brick for £100 or a 6-line brick for £150) and complete the application form overleaf.

This is a limited time offer dependant on space available so please choose your brick ASAP to create your living legacy at our centre.

Bricks will be installed once the building work is complete, which is planned for late 2023 and all brick owners will be invited to the grand opening, where you will see your brick in situ.
